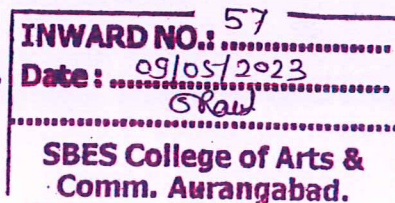


Sir / Madam,

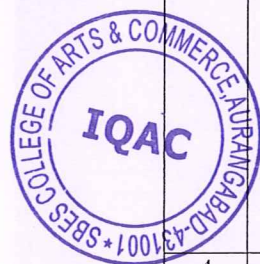


